- 1. The regulations in table A in the Forth Schedule to the Companies Act 1965 shall Adoption of Table A apply except so far for those as specified or contained therein in these Articles.
- 2. The Company is a private company and accordingly:-
 - (a) The right to transfer shares is restricted in manner hereinafter prescribed;
 - (b) The number of members of the Company (counting joint holders of shares as one person and not counting any person in the employment of the Company or of its subsidiary or any person who while previously in the employment of the Company or of its subsidiary or any person who while previously in the employment of the Company or of its subsidiary was and thereafter has continued to be a member of the Company) shall be limited to fifty; provided that where two or more person hold one or more shares in the Company jointly they shall for the purposes of this paragraph be treated as a single member;
 - (c) Any invitation to the public to subscribe for any shares in or debentures of the Company is prohibited;
 - (d) Any invitation to the public to deposit money with the company for fixed periods or payable at calls, whether bearing or not bearing interest, is prohibited.

- 4. Until and unless otherwise determined as aforesaid the number of directors shall . be not less than two and not more than nine.
- 5. A resolution in writing signed by a majority of the directors for the time being or their alternates not being less than two directors shall be as valid and effectual as if it had been passed by a meeting of directors duly called and constituted.
- 6. The first secretary shall be KHOO TECK KEE (MIA 21118) and TAN CHEE LUEN (MIA 14582).


