

- 1. The name of the Company is MY FLAVOR FOOD SDN. BHD.
- 2. The registered office of the Company will be situated in Malaysia.
- 3. The objects for which the Company is established are -
  - (1) To carry on business as manufacturing of food ingredients or F&B value added compound.
