- 1. Open internet browser and type https://ssm4u.com.my.
- 2. Click "REGISTER" to register user ID.

- 4. Click icon "DCTC READER & CHECKER"
- 5. Key in Serial No, complete reCAPTCHA and click "SEARCH" button.
- 6. Ensure the copy viewed in internet browser matches the printed copy.

- 1. Install "SSM DCTC QR READER" from Google Play (Android) or App Store (iOS) on smartphone.
- 2. Run the application.
- 3. Press "TAP SCREEN TO SCAN" and point your smartphone camera to the QR Code that can be found at the bottom of digital certified true copy document.
- 4. The Smartphone will display the original copy of the document store in SSM database that has been digitally certified by POS Digicert Sdn Bhd.
- 5. Ensure the copy appeared in the smartphone matches the printed copy.
