



 - (iii) TO BUY PROPERTIES, HOUSES, LAND OR OTHERWISE ACQUIRE SHARES, STOCKS, DEBENTURES OR OTHER SECURITIES ISSUED BY ANY OTHER COMPANY TO INVEST UPON OR WITHOUT SECURITY THE MONEYS OF THE COMPANY IN SUCH MANNER AS MAY FROM TIME TO TIME BE DETERMINED AND TO HOLD ANY SUCH SHARES, SECURITIES OR INVESTMENTS OR AT ANY TIME OR TIMES TO SELL, REALISE THE SAME AND TO REINVEST THE PROCEEDS.

 Subject as hereinafter provided, the regulations contained in Table A in the Fourth Schedule of the Companies Act, 1965 shall apply to the Company with the exception of Regulations 71 and 90 of Table A.

PRIVATE COMPANY

- 2. The Company is a private company, and accordingly:-
